### PREA Statistics:

The **Prison Rape Elimination Act of 2003** was enacted by Congress to address the problem of sexual abuse of persons in the custody of U.S. correctional agencies.

**Major provisions of PREA include:**

- Adherence to a zero-tolerance standard for the incidence of inmate sexual assault and rape;
- Development of standards for detection, prevention, reduction, and punishment of prison rape;
- Collection and dissemination of information on the incidence of prison rape; and
- Award of grant funds to help state and local governments implement the purposes of the Act.

DeKalb County Sheriff's Office has partnered with **Day League Sexual Assault care and Prevention, DeKalb County Police Sex Crimes Unit, and Grady Hospital** to provide additional resources to victims in our facility.
