2019 **P**riso**n** **R**ape **E**limination **A**ct (PREA) Report

The Prison Rape Elimination Act of 2003 was enacted by Congress to address the problem of sexual abuse of persons in the custody of U.S. correctional agencies. DeKalb County Sheriff's Office has partnered with **Day League Sexual Assault Care and Prevention, DeKalb County Police Sex Crimes Unit, and Grady Hospital** to provide additional resources to victims in our facility.
